- Requests must be consistent with the values and missions of Farm Credit of the Virginias.
- Farm Credit of the Virginias will not provide critiques of proposals submitted.
- Funds will not be awarded individuals or private farms.
- Farm Credit of the Virginias may choose to fully or partially fund requests. Previous funding does not guarantee continuing support to any organization. Funding is discretionary and restricted to a specific purpose.

Restrictions

- Program and projects of charities that do not support agriculture or agricultural education.
- Contributions for political support purposes, scholarships or memberships in professional societies or trade organizations.
- Individual or personal endeavors or projects, or individual farm operations.
- Participation or entrance fees for charitable events or financing of charitable organizations.
- Religious or sectarian programs or groups that benefit the specific organization.
- Political campaigns, candidates, lobbying groups, or causes. Sports teams or athletic events and competition, including equipment or uniforms related to sports.
- School activities that are not related to agriculture (bands, choirs, fine arts programs, etc.).
- Private foundations promoting personal hobbies.
- Organizations or programs that are inconsistent with or do not align with non-discrimination, ethics, or other FCV policies, values or mission.
- Organizations that in any way pose a conflict with Farm Credit of the Virginias' goals, programs, services, or Farm Credit of the Virginias employees or Directors.
